TITLE: RESOLUTION AUTHORIZING FASTECH CONSULTING ENGINEERS TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR CONSTRUCTION INSPECTION AND ADMINISTRATION SERVICES TO THE BOROUGH OF ENGLEWOOD CLIFFS IN SUPPORT 2026 ROAD PAVING PROGRAM AND ASSOCIATED WORK VIA THE RIVERSIDE CO-OP IN AN AMOUNT NOT TO EXCEED \$69,320.00

WHEREAS, the Borough of Englewood Cliffs (“Borough”) annually undertakes roadway paving and associated improvements; and

WHEREAS, the Borough intends to proceed with the 2026 Road Paving Program, to be procured through the Riverside Co-Op, including milling and resurfacing of identified roadways and selective curb replacement; and

WHEREAS, Fastech Consulting Engineers. (“Fastech”) has submitted a proposal dated April 1, 2026, to provide professional engineering services including field evaluation, procurement support, construction administration, and construction inspection; and

WHEREAS, the fee for these services shall not exceed \$69,320.00, to be invoiced in accordance with the authorizing resolution;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Englewood Cliffs, County of Bergen, State of New Jersey, that:

1. The Borough hereby authorizes Fastech Consulting Engineers to provide professional engineering services for the 2026 Road Paving Program and associated work via the Riverside Co-Op, in an amount not to exceed \$69,320.00.
2. The Mayor and Borough Clerk are authorized to execute any and all documents necessary to effectuate this authorization.
3. This resolution shall take effect immediately.

BE IT FURTHER RESOLVED, that the Chief Financial Officer has certified that funds are available in Bond Ordinance # 2026-08 (C-04-26-008-000)
