TITLE: RESOLUTION APPROVING APPLICATIONS FOR TOWING LICENSES AND PLACEMENT ON THE ROTATING TOWING LIST: ABC TOWING, KELLY'S VALERO SERVICES, SANO'S TOWING, AND APEX AUTO BODY

WHEREAS, the following businesses have submitted applications to be approved as towing companies, for issuance of towing licenses, and to be placed upon the rotating on-call towing list pursuant to Chapter 88 of the Code of the Borough of Englewood Cliffs:

- **ABC Towing**, 1580 Bergen Boulevard, Fort Lee, New Jersey
- **Kelly's Valero Services**, 2470 Lemoine Avenue, Fort Lee, New Jersey
- **Sano's Towing**, 344 Bergen Boulevard, Palisades Park, New Jersey
- **APEX Auto Body**, 1490 Bergen Boulevard, Fort Lee, New Jersey; and

WHEREAS, investigations of the above-referenced applications were completed by the Borough of Englewood Cliffs Police Department and reported to the Mayor and Council of the Borough of Englewood Cliffs; and

WHEREAS, the Mayor and Council of the Borough of Englewood Cliffs have reviewed the investigation reports of the Police Department, together with the Borough ordinances regulating towing services, and have determined that the applicants have met all requirements for approval as towing companies and placement on the rotating on-call list; and

WHEREAS, the Mayor and Council of the Borough of Englewood Cliffs find that the above-named businesses are qualified and competent to provide on-call towing services on a rotating basis for the Borough of Englewood Cliffs;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Englewood Cliffs, County of Bergen, State of New Jersey, that ABC Towing, Kelly's Valero Services, Sano's Towing, and APEX Auto Body are hereby approved as towing companies, and their applications for towing licenses are hereby approved, subject to compliance with all applicable provisions of Chapter 88 of the Code of the Borough of Englewood Cliffs and any conditions imposed by the Borough and Police Department; and

BE IT FURTHER RESOLVED, that the above-named towing companies are hereby placed on the rotating on-call towing list for the Calendar Year 2026, and shall provide towing services on an on-call, rotating basis, subject to continued compliance with all Borough ordinances, rules, and regulations governing towing services.
