TITLE: RESOLUTION APPROVING PROFESSIONAL SERVICES CONTRACT WITH THE CANNING GROUP, LLC AND APPOINTING SEAN P. CANNING AS QUALIFIED PURCHASING AGENT (QPA)

WHEREAS, the Borough of Englewood Cliffs (the "Borough") requires the services of a Qualified Purchasing Agent ("QPA") under the Local Public Contracts Law; and

WHEREAS, Sean P. Canning of The Canning Group, LLC has provided the Borough with a proposed Services Agreement to perform such QPA services during 2026 at a total cost not to exceed \$10,000.00; and

WHEREAS, the Borough finds that Sean P. Canning of the Canning Group possesses the required qualifications and experience necessary to perform the needed QPA services; and

WHEREAS, the Borough desires to approve a professional services contract with Sean P. Canning of The Canning Group to perform QPA services for the Borough; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Englewood Cliffs, County of Bergen, State of New Jersey, hereby approve the Services Agreement, with Sean P. Canning of The Canning Group as the Qualified Purchasing Agent until December 31, 2026, at a cost not to exceed \$10,000.00; and

BE IT FURTHER RESOLVED that the Borough Administrator is hereby authorized to execute the Services Agreement; and

BE IT FURTHER RESOLVED that a copy of this Resolution, together with the executed Services Agreement, shall be forwarded to the Borough Administrator and The Canning Group, LLC.


