**WHEREAS**, the Borough of Englewood Cliffs (the “Borough”) has determined that it is necessary for a Special Counsel to represent the Borough with respect to certain legal services of the Borough, including those of representing the Borough in litigation.

**WHEREAS**, the Borough has determined that it is in the best interest to retain the professional set forth in this Resolution; and

**WHEREAS**, the Borough has reviewed the credentials of Jardim Meisner Salmon Sprague & Susser P.C. located at 30B Vreeland Road, Suite 100, Florham Park, NJ 07932, and has found that he has the requisite professional experience to assist the Borough; and

**WHEREAS**, the Borough seeks to enter into a Professional Services Agreement with the Law Office of Jardim Meisner Salmon Sprague & Susser P.C. of for performance of the professional services set forth above between January 1, 2026, and December 31, 2026, for services as Special Counsel at a blended hourly rate of \$215.00 per hour for a cost not to exceed \$25,000. There will be no charge for overhead or for time spent by paralegals or staff. Costs and expenses will be billed separately and at a mutually agreed upon rate; and

**WHEREAS**, the proposed contract is awarded pursuant to a fair and open process., and the professional shall confirm adherence to all Pay to Play laws; and

**WHEREAS**, the proposal for services is for an hourly rate on an as needed basis, and the Chief Financial Officer will certify available funds at the time the services are requested.

**WHEREAS**, the exact line-item appropriation is Legal Services OE: 6-01-20-155-200.

**NOW, THEREFORE, BE IT RESOLVED** that Mayor Mark Park be and the same is hereby authorized to execute and deliver the Professional Services Agreement in conformance with this resolution; and

**IT IS FURTHER RESOLVED** that the Borough Clerk will advertise public notice of this appointment in accordance with law, and a copy of the Professional Services Agreement authorized by this resolution, once executed, shall be kept on file with the Borough Clerk and available for inspection.


