**TITLE: APPOINTMENT OF MUNICIPAL SPECIAL / CONFLICT COUNSEL:
RICHARD MALAGIERE, P.C.**

WHEREAS, the Borough of Englewood Cliffs (the "Borough") has determined that it is necessary for a Special Counsel to represent the Borough with respect to certain legal services of the Borough, including those of representing the Borough in litigation.

WHEREAS, the Borough has determined that it is in the best interest to retain the professional set forth in this Resolution; and

WHEREAS, the Borough has reviewed the credentials of Richard Malagiere, P.C. located at 250 Moonachie Road, Suite 300A, Moonachie, NJ 07074, and has found that the firm has the requisite professional experience to assist the Borough; and

WHEREAS, the Borough seeks to enter into a Professional Services Agreement with the Law Office Richard Malagiere, P.C. of for performance of the professional services set forth above between January 1, 2026, and December 31, 2026, for services as Special Counsel at a blended hourly rate of \$215.00 per hour at a cost not to exceed \$25,000. There will be no charge for overhead or for time spent by paralegals or staff. Costs and expenses, including computer research costs, will be billed separately and a mutually agreed upon rate; and

WHEREAS, the proposed contract is awarded pursuant to a fair and open process., and the professional shall confirm adherence to all Pay to Play laws; and

WHEREAS, the proposal for services is for an hourly rate on an as needed basis, and the Chief Financial Officer will certify available funds at the time the services are requested.

WHEREAS, the exact line-item appropriation is Legal Services OE: 6-01-20-155-200

NOW, THEREFORE, BE IT RESOLVED that Mayor Mark Park be and the same is hereby authorized to execute and deliver the Professional Services Agreement in conformance with this resolution; and

IT IS FURTHER RESOLVED that the Borough Clerk will advertise public notice of this appointment in accordance with law, and a copy of the Professional Services Agreement authorized by this resolution, once executed, shall be kept on file with the Borough Clerk and available for inspection.


